Foreclosure Prevention Services Offered to Local Homeowners Hoping to Keep Their Homes

Since September 2007, CEDC's NeighborWorks[®] HomeOwnership Center (HOC) has offered free foreclosure prevention counseling and workshops to assist the Ventura County community in maintaining homeownership. It began offering the same services in the Santa Maria area when it opened its HomeOwnership Center in December 2007. HOC counselors are certified by the U.S. Department of Housing and Urban

Development (HUD) and certified in foreclosure prevention by NeighborWorks® America.

The HOC has been providing sound financial and homeownership education since 1999 and offered a foreclosure clinic on June 20 in Ventura. 

From Boat to Land-Family Buys Home with Responsible Loan Through CEDC's NeighborWorks® HomeOwnership Center

Partnering with the City of Ventura to Enable Employees to Live Near Their Jobs

When the City of Ventura announced a new housing assistance program a few years ago, Dave and Laura Hughart wondered if homeownership might be possible for them. Although they loved living on the boat Dave finished building 18 years ago, the idea of living in a home on land seemed like more of a possibility than ever before.

The city's plan offers qualifying staff members, such as Dave who has worked in the city's information technology department for 10 years, the opportunity to finance a home purchase using citysupported funding at no more than 30% of the purchase price or \$150,000, whichever is less, either as an amortized second mortgage loan, or as an equity-share arrangement. Participating employees must put a minimum of 5% down. Income generated from loan

interest, or equity share income, is funneled back into the program to fund future home purchase opportunities.

The Hughart family, including daughters Lauren and Emma, and their dog Maye, moved into their new home in March. The neighbors even brought cookies and a note to welcome them. They appreciate the quality service they received from CEDC's NeighborWorks® HomeOwnership Center (HOC) staff including the first-time homebuyer class they took more than a year ago. They purchased the home with a 30-year fixed first mortgage arranged through CEDC's Ventura County Community Development Corporation (VCCDC). "In the end, it came down to the

monthly payment, what we could afford and what made sense for us," says Laura. "It feels like we're going to make a really nice life in this house."

"The HOC staff was always positive and helpful, and they knew what they were doing," says Dave. "They really assisted us by guiding us through the process every step of the way."
